**ORDER**

Ld. Counsel Mr. Naveen Kumar Murthi is present for the Applicant.

1. This is an application filed by the Applicant Companies seeking condonation of delay of 686 days in filing e-Form INC 28 with the Registrar of Companies, Chennai, as required in vide order dated 23.12.2022 in CP (CAA) No. 58/(CHE)/2022.

It is submitted in the para no.4 of the petition that the delay from the part of Applicant Companies was caused due to procedural requirements in obtaining and surrendering the Certificate of Registration as an NBFC from the Reserve Bank of India, which was a pre-requisite for making the Scheme effective. The 2nd Applicant Company received its Certificate of Registration only on 20.12.2024, after which the e-Form INC 28 was filed.

3. It is further submitted that as per the definition of "Effective Date" in clause 2(x) of the Scheme as approved by the Hon'ble NCLT and paragraph 9(vi) of the NCLT order, so as to the 'Effective Date' as:

***"The 'Effective date' shall mean the date on which the 2nd Petitioner Company is 'in receipt of the Final NBFC Licenced or filing the copy of the order of Tribunal approving this Scheme with the jurisdictional Registrar of Companies, whichever is later."***

Since the NBFC registration process was completed only on 20.12.2024, the filing of e-Form INC 28 thereafter was in accordance with the effective implementation of the Scheme.

4. Heard the applicant. Upon perusal of records, this Tribunal finds that the reasons cited by the Applicant Companies are genuine. Hence, the delay of 686 days in filing e-Form INC 28 is condoned and the filing of e-Form INC 28 by the Applicant Companies with the ROC, Chennai, on 20.12.2024, is taken on record. The effective date shall be read as 04.03.2025. **Therefore, I.A.(CA)/ 15**

**(CHE)/2025 is hereby disposed off.**
